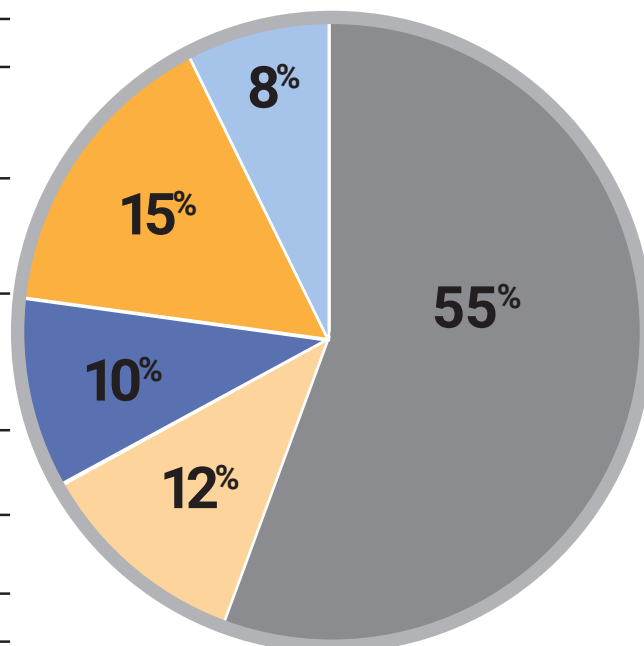

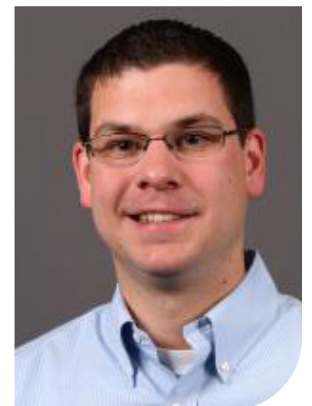
Why did you volunteer for United Way?

support for community members and agencies.

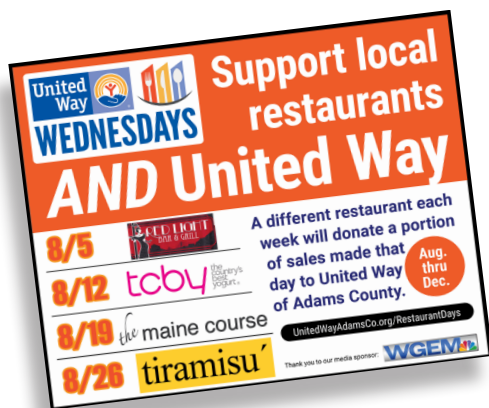
Why are you encouraged for the future of United Way?

Throughout its 83-year history, United Way has been connecting people and resources

Through generous support by companies and individuals across Adams County, United Way supports 28 partner agency programs, numerous county-wide initiatives and community support services. United Way and its partners impact over 34,000 people each year – roughly 46% of all residents in Adams County.

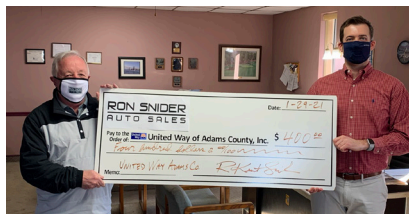
